The Bank has disposed of 93.43111% of treasury shares, or 2.46293% of the total number of issued ordinary shares.

III. Grounds, manner and date of disposal of treasury shares that are the subject-matter of the notification:

The treasury shares that are the subject-matter of this notification have been disposed of in the process of Offer for sale (disposal) of the Bank's ordinary shares to all shareholders, legal holders of ordinary shares, in accordance with the provisions of Article 288 of the Company Law and the Rules of Operation of the Central Securities Depository and Clearing House, on the basis of the Decision on the sale (disposal) of the Bank's treasury shares No. 196/4, adopted at the General Meeting of the Bank's Shareholders, held on 18.04.2022.

The offer was executed immediately upon adoption of the Decision of the General Meeting of the Bank's shareholders and lasted from 20.04.2022 to 20.05.2022 i.e. 30 days.

Date of netting the transaction: 23.05.2022, price 4,1765.3 dinars per ordinary share.

IV. Additional information on the disposal and the total number of the Bank's treasury shares:

On the date of releasing this notification, NLB Komercijalna banka AD Beograd holds a total of 31,994 treasury shares, which is 0.17316% of the total number of issued ordinary shares or 0.16973% of the total number of issued shares of both types (ordinary and preferred ones).
