- 6) Business plan of the Energoprojekt Group for 2009 for the second half of 2009 includes a total consolidated revenue of the Group in the amount of EUR 95,7 million and consolidated gross profit in the amount of EUR 3,4 million. For the first half of 2009 the total consolidated revenue is planned to be in the amount of EUR 143,0 million and consolidated gross profit in the amount of EUR 5,5 million. The realized consolidated revenue in the first half of 2009 amounted to EUR 130,8 million, which is 91% more than planned and the consolidated gross profit amounted to EUR 5,6 million, more exactly 102% of the semi-annual plan. Up to the date of announcing of this statement the company has had business within the limits of the planned business goals and there has been no important material events and transactions which would have a significant impact on the operations of the company.
